Subject: Regarding issuance of No Objection Certificate for securing affiliation with C.B.S.E., New Delhi.

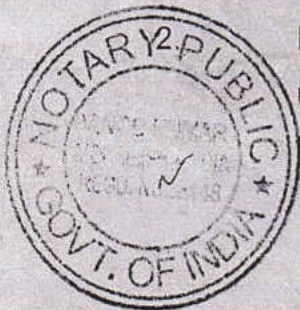

2. After keen consideration of the documents presented as well as the oral deposition, as made by the management of your school & recommendations, as made by the District Education Officer, Ropar as well as D.P.I., Private Aided (s), the Government of Punjab issues the requisite No Objection Certificate on the following terms & conditions:-

1. If at any time in future, such facts come to light, as a result of any complaint/inspection that at the time of obtaining No Objection Certificate, fabricated information was furnished to the Government, while making a request for the same by your/or if the instructions as issued by the State Government from time to time do not stand a test of compliance on your side & the written conditions as mentioned in the oral deposition are not kept in word & spirit, then, the annulment of the No Objection Certificate, under such circumstances can be made at any time.

It will be mandatory for your school to impart education in Punjabi upto class Xth level & C.B.S.E. will definitely make arrangement to hold examination of Punjabi in such schools & it is also stated here

After securing affiliation with the C.B.S.E., the Management of the school will be committed to pay its teaching as well as non-teaching staff, the salaries and other allowances etc. at parity with the Government employees. Non-compliance with the same will amount to the immediate annulment of the No-Objection Certificate.
- 4. You and your management will ensure that whenever an access to any information is desired by the District Education Officer of the District in which your School is being run or any of the senior functionaries of the Education Department, then the same will be made available to him together with the needed assistance.
